Please note: Sec. 12-60 of the Town Code of Ordinances states "*Tree trunks, roots and root balls produced as a result of tree maintenance or removal will not be removed by the town's refuse collection company; Therefore, removal of such material is the responsibility and obligation of the property owner.*"

**12.58(b) After an application is filed and all applicable requirements are in compliance, a permit shall be issued if one or more of the following criteria is met:**

- Signed report by licensed engineer that tree presents a safety hazard to property due to proximity to structure.
- A certified arborist signs a report that the tree is diseased, injured, or in declining condition with no recovery possible.
- Licensed architect, licensed landscape architect, or licensed engineer certifies that the tree is located in an area where a structure or improvement will be placed or that serves as an access point to a site according to an approved plan, and the structure improvement or access point cannot be reasonably redesigned to save the tree.
- Tree is within a site that has the minimum number of trees required by the Town code and removal will allow the site to be used in a similar way like other properties in the zoning district.
- Solar equipment requires sun and the tree is providing too much shade. Solar installer or licensed architect provides documents that there is no reasonable alternative location for the equipment or reasonable option to trim the trees.
